



Coronavirus (COVID-19) catch-up premium

The government COVID-19 catch-up premium has been established to mitigate the effects of the unique disruption caused by coronavirus. The grant will only be available for the 2020-2021 academic year. Schools should use this funding for specific activities to support pupils to catch up for lost teaching time over the previous months. To support schools to make the best use of the funding, the EEF has published a support guide:

Therefore, the impact and spending strategy for this catch-up premium will be reviewed in meetings with the headteacher throughout the 2020-2021 academic year, and report to the governing academic committee

When Ofsted re-commence routine inspections, they will make judgements about the quality of education being provided which will include how the funding is being used to ensure the curriculum has a positive impact on all pupils.
