Context of Risk Assessment

On the 8th September school will fully reopen with Boarders returning from 7th September. The opening will be a phased one to allow for lateral flow testing round 1 before students restart school. All students will be in school by Friday 10th September.

During half term we received a letter from Somerset Public Health (as did a number of other local secondary schools) recommending additional measure are put in place for 2 weeks. This RA reflects those additional measures.
